## ORDERS

The Commissioner of Collegiate Education has forwarded the application submitted by the Vivekananda Educational Trust Erode, to open a co-educational united parameter according to the name of Bharkthidasan College of Arts and Science at Education has stated that the management has provided the following:

- i. An Endowment of Rs. 10/-(Rupees ten lakhs only) has been created in the joint name of Commissioner of Collegiate Education and Vivekananda Educational Trust with the City Union Bank Limited, Erade, Periyar District.
- ii) The Management has purchased 13.44 Acres of Land at Pallapalayam Perundurai Taluk and Periyapuliyre Taluk situated 16kms away from Erode in Survey Nes.731/1 to 18 and 639/1 to 18 and the document relating to the above land is registered in the name of the Trust and the above land is in one complete block. Compact block
- iii) Agreement in stamp paper to abide by all terms and conditions prescribed by the Government.

- 2) The Government have examined the proposal carefully and they permit Vivekananda Educational Trust, Erode to open a co-educational self-financing private college in the name and style of Tharathidasan College of Arts and Science at Ellispettal, Bhavani Taluk. Periyar District during 1994-95 with the following courses.
  - 1) B.Sc., Computer Science
  - 2) B.Sc., Bi-Chemistry
    - 3) B.Sc., Micre Bielegy
  - 4) B.Sc., Visual Communication
  - 5) B.B.M.
- during 1994-95 temperarily at the buildings taken on lease for one year at Deer Nes.66 and 25 in Gandhi Nagar, Erode and it should be shifted to the permanent building to be constructed in the land mentioned in para 1 (11) above, during 1995-96.
- subject to the conditions: granted in para 2 above is also
- 1) Affiliation from the Bharathiar University,'
  Coimbatore should be obtained for the college from the year
  1934-95 and before the commencement of all courses of study.
- not be utilised for any purpose other than college purpose.
- assistance at any time.
- 4) The management should satisfy all the conditions prescribed in G.W.Ms.No.858, Education, dated 15-7-39.
- Arts and Commerce courses, allowed by the Government Spriversity should be conducted.
- appointed as per the yardstick and they should possess the prescribed qualifications.
- 7) If the management creates a situation causing the closure of the cellege for any reasons, the Covernment will not come ferward to take over.
