ORDERS:

The Commissioner of Collegiate Education has forwarded the application submitted by the Vivekananda Educational Trust Erode, to open a co-educational ~~unaided private~~ college in the name of 'Bharthidasan College of Arts and Science at Ellispettai, Bhavani Taluk, Periyar District. The Commissioner of Collegiate Education has stated that the management has provided the followings

i. An Endowment of Rs.10/- (Rupees ten lakhs only) has been created in the joint name of Commissioner of Collegiate Education and Vivekananda Educational Trust with the City Union Bank Limited, Erode, Periyar District.

ii) The Management has purchased 13.44 Acres of Land at Pallapalayam Perundurai Taluk and Periyapuliye Taluk situated 16Kms away from Erode in Survey Nos.731/1 to 10 and 639/1 to 18 and the document relating to the above land is registered in the name of the Trust and the above land is in one ~~complete block.~~ compact block

iii) Agreement in stamp paper to abide by all terms and conditions prescribed by the Government.

2) The Government have examined the proposal carefully and they permit Vivekananda Educational Trust, Erode to open a co-educational self-financing private college in the name and style of 'Bharathidasan College of Arts and Science at Ellispethai, Bhavani Taluk, Periyar District during 1994-95 with the following courses.

- 1) B.Sc., Computer Science
- 2) B.Sc., Bio-Chemistry
- 3) B.Sc., Micro Biology
- 4) B.Sc., Visual Communication
- 5) B.B.M.

3) The management is permitted to start the college during 1994-95 temporarily at the buildings taken on lease for one year at Door Nos.66 and 25 in Gandhi Nagar, Erode and it should be shifted to the permanent building to be constructed in the land mentioned in para 1 (ii) above, during 1995-96.

4) The permission granted in para 2 above is also subject to the conditions:

1) Affiliation from the 'Bharathiar University, Coimbatore' should be obtained for the college from the year 1994-95 and before the commencement of all courses of study.

2) The land mentioned in para 1(ii) above should not be utilised for any purpose other than college purpose.

3) The Government will not grant any financial assistance at any time.

4) The management should satisfy all the conditions prescribed in G.O.Ms.No.858, Education, dated 15-7-89.

5) No other courses of study except Science, Arts and Commerce courses, allowed by the Government University should be conducted.

6) The teaching and non-teaching staff shall be appointed as per the yardstick and they should possess the prescribed qualifications.

7) If the management creates a situation causing the closure of the college for any reasons, the Government will not come forward to take over.
